

ANNOUNCEMENT**Implementation of the Residential Off-Peak Tariff Timetable
for the winter period 2016-2017**

The Residential Off-peak tariff timetable will apply between 01.11.2016 and 30.04.2017 as follows:

1. Residential customers:

- living in the Municipalities and Communities across the Prefecture of Attica
- living in the wider areas of the following cities: Agrinio, Aiginio, Aigio, Aitoliko, Aktio, Alexandroupoli, Almyros (Magnisia), Amaliada, Amyntaio, Amfiklia, Amfilochia, Amfissa, Axioupoli, Argos, Arta, Astros, Veria, Volos, Giannitsa, Grevena, Didimoticho, Distomo, Domokos, Drama, Edessa, Eliki, Epidavros, Igoumenitsa, Zakynthos, Thiva, Iasmos, Ioannina, Kavala, Kalamata, Kalambaka, Kanalaki, Karditsa, Karpenisi, Kassandria, Kastoria, Katerini, Kefallonia, Kiato, Kilkis, Kozani, Komotini, Korinthos, Kranidi, Kyparissia, Lagadas, Lagadia (Arkadia), Lamia, Larisa, Lefkada, Livadia, Nikiti, Methana, Metsovo, Molaoi, Moudania, Nafpaktos, Nafplio, Naousa, Xanthi, Xylokastro, Patra, Platamonas, Polygyros, Preveza, Provatonas, Ptolemaida, Pylos, Pyrgos, Oinofyta, Orestiada, Servia, Serres, Sidirokastro, Sofades, Skala, Skydra, Sparti, Stageira, Stylida, Schimatari, Trikala, Tripoli, Florina
- living on the islands of Evia, Kea, Corfu, Skiathos, Skopelos and Alonnisos

the off-peak timetable will be implemented on the basis of 2 different timeframes:

1.1. Continuous (23:00–07:00): 8 continuous hours per day. This will apply to consumers who have already been using it and wish to continue to use it as is.

1.2. The 2-timeframe timetable, i.e., 2 hours in the afternoon (15:00-17:00) and 6 hours at night (02:00–08:00), i.e., a total of 8 hours. This will apply to the following consumer groups:

- Consumers who have used the 2-timeframe timetable: 02:00-08:00 and 15:00-17:00 until 30.04.2013.
- New consumers who have applied for an off-peak tariff and will be entitled to this tariff only.
- Consumers who use continuous timetable and wish to switch over to the 2-timeframe one (but will not be entitled to change back to the continuous one).



2. Residential consumers living in the wider area of Thessaloniki will have 2 options:

2.1. Continuous (23:00-07:00). This will apply to consumers who have already been using it and wish to continue to use it as is.

2.2. Off-peak in 2 timeframes within the day: 02:00–08:00 and 15:00–17:00 (8 hours a day). This will apply to consumers who have used the 2-timeframe timetable: 02:00-08:00 and 15:00-17:00 until 30.04.2013. Those who have opted for the 23:00–07:00 timetable and wish to switch over to the 2-timeframe one, i.e., 02:00–08:00 and 15:00–17:00, they can do so but will not be entitled to change back to the continuous one.

3. As regards the island of Crete (in the wider areas of the cities/towns of Heraklion, Rethymnon, Ierapetra, Agios Nikolaos, Siteia, Chania, Stalida (Heraklion) Moires (Heraklion), Praitoria (Heraklion), Vryses (Chania), Agia (Chania), and the islands of Heraklia, Ios, Kalymnos, Koufonisia, Kos, Leipsoi, Leros, Lesvos, Limnos, Milos, Naxos, Nisyros, Paros, Rhodes, Samos, Santorini, Sikinos, Syros, Schoinousa, Tilos, Folegandros, Chalki, Chios, the following will apply:

3.1. There are two options for the off-peak tariff: the continuous one (23.00-07.00) and the 2-timeframe one (02.00-08.00 and 15.30-17.30).

3.2. The 2-timeframe one is the only option available to new residential consumers wishing to apply for the off-peak tariff.

There is no change for consumers currently using the continuous tariff. In case they wish to switch over to the 2-timeframe tariff, they can do so by applying to the competent HEDNO SA office, but they will not be entitled to change back to the continuous one.

3.3. Continuous timetable will no longer be implemented to new consumers and will only be granted to those who have been using it already. In geographical areas using a time switch, only the continuous timetable will apply.

4. For residential consumers living in the rest of the country the continuous off-peak timetable (23:00-07:00) will apply as is today.
