In accordance with article 2 of Joint Ministerial Decision YΠΕΝ/ΔΑΠΕΕΚ/48653/1597/29.05.2019 (GG 2172/B/07.06.2019), Residential Accounts in Local Communities with RES facilities and Hybrid Stations which were active on 31.07.2020, the date of publication of the "Final Table Including the Breakdown of Costs from RES Facilities in one or more Municipal or Local Communities for years 2015-2019", are eligible for the refund/return of the Special 1% RES Fee.
