

ANNOUNCEMENT

APPLICATION OF THE RESIDENTIAL NIGHT TARIFF FOR THE WINTER PERIOD 2015-2016

The timetable of the Residential Night Tariff from 1.11.2015 until 30.04.2016 applies as follows:

- 1. For residential customers who live in:
 - All Municipalities and Communities of the Attica Prefecture
 - The wider areas of the cities: Agrinio, Aiginiou, Aigio, Aitoliko, Aktio, Alexandroupoli, Almiros, Magnisia, Amaliada, Amyntaio, Amfiklia, Amfiloxia, Amfissa, Axioupoli, Argos, Arta, Astrous, Veroia, Volos, Giannitsa, Grevena, Didimotichos, Distomos, Domokos, Drama, Edessa, Elikis, Epidavros, Igoumenitsa, Thiva, Iasmos, Ioannina, Kavala, Kalamata, Kalabaka, Kanalakiou Karditsa, Karpenisi, Kassandria, Kastoria, Katerini, Kiato, Kilkis, Kozani, Komotini, Korinthos, Kranidi, Kyparissia, Lagada, Lagadion Arcadias, Lamia, Larisa, Lefkada, Livadia, Nikiti, Methana, Molaoi, Moudania, Nafpaktos, Nafplion, Naoussa, Xanthi, Xylokastro, Patra, Platamonas, Polygyros, Preveza, Provatona, Ptolemaida, Pylos, Pyrgos, Oinofyta, Orestiada, Servion, Serres, Sidirokastro, Sofades, Skalas, Skydra, Sparti, Stageira, Stylida, Sximatari, Trikala, Tripoli, Florina
 - The islands of Evia, Kea, Corfu, Skiathos, Skopelos and Alonnisos

The night tariff is applied in 2 timetables:

- 1.1 The continuous timetable (23:00-07:00) with duration of 8 hours. It is applied to consumers who already use it and who do not wish to change it.
- 1.2 The segmented timetable, that is, 2 hours in the afternoon (15:00-17:00) and 6 hours at night (02:00-08:00) that is, 8 hours in total. It is applied to the following consumer groups:
- Consumers who have already used the segmented timetable 02:00-08:00 and 15:00-17:00 until 30.04.2013.
- New consumers who request for night tariff and will use this timetable only.
- Consumers who have continuous timetable and wish to change it to segmented (afterwards they cannot return to the continuous timetable).



- 2. For residential consumers of the wider area of Thessaloniki, the night tariff is applied in 2 timetables:
 - 2.1 The continuous timetable (23:00-07:00). It is applied for consumers who already use it and who do not wish to change it.
 - 2.2 The night tariff with segmented timetable 2:00-8:00 and 15:00-17:00 (8 hours within 24 hours). It is applied to consumers who have already used the segmented timetable 2:00-8:00 and 15:00-17:00 until 30.04.2013. All those who have timetable 23:00-07:00 and wish to change it, they can use the segmented timetable 02:00-08:00 and 15:00-17:00 but they can no longer return to the continuous timetable.
- 3. In the island of Grete (in the wider areas of the cities of Iraklio, Rethimno, Ierapetra, Agios Nikolaos, Sitias, Chania, Stalida in Iraklio, Moires in Iraklio, Praitoria in Iraklio, Vrises in Chania and Agia in Chania) as well as in the islands of Iraklia, Ios, Kalimnos, Koufonisia, Kos, Leipsi, Leros, Lesvos, Naxos, Nisiros, Paros, Rhodes, Samos, Sikinos, Schinousa, Tilos, Folegandros, Chalki, Chios apply the following:
 - 3.1 The tariff is applied in two timetables, the continuous (23:00-07:00) and the segmented timetable (2:00-08:00 and 15:30-17:30).
 - 3.2 The segmented timetable is applied obligatorily to all new residential consumers who request for night tariff.

The consumers who use up today the continuous timetable will continue to use it. If they wish to change it to the segmented timetable, they can ask for it at the competent office of HEDNO S.A., but they can no longer return to the continuous timetable.

- 3.3 The continuous timetable is no longer applied to new consumers and it is supplied only to those who already use it. In geographic areas where time switches operate, only the continuous timetable will be provided.
- 4. For residential consumers of the rest of the country, the night tariff is applied with the continuous timetable (23:00-07:00), that is, as it is applied today.
